Before You Start

Before lacing up those dance shoes, it is important that all families – whether returning or new – sign their online waivers and update their contact info through the online Parent Portal so we can ensure we have the most up-to-date contact details for you. Online policies include our Terms & Conditions, General Liability Waiver, Voluntary Assumption of Risk, Model Release (so we can show off photos and videos of our amazing dancers in and around the studios), Medical Information and Auto-Pay Agreement. These policies are also included later in this Studio Handbook. Please also take a moment to ensure your payment information is correct and up-to-date.

All registrations are handled through our online system - Jackrabbit. If it's your first time registering with Element Dance Arts, you'll be required to create an account through the Registration link on our website. Once your account is created, you can access it through our Parent Portal at anytime.

We encourage all of our students and families to try a variety of dance styles and we are more than happy to accommodate trial classes for existing students who are wanting to try something a bit different. Full Time Program Information

Our Full Time program has been developed to produce strong, well-rounded dancers wishing to train at an advanced level. Dancers in the Full Time program are expected to be dedicated to training in a disciplined, technique-intensive program. Program requirements vary by age group, and are listed below. Additional classes may be added for those wishing to train in more genres than required.

Dancers who train in the Full Time program are also invited to be members of the EDA Full Time competitive team. Each company will have 2 competitive group dances choreographed in their technique classes. There will be no additional choreography fees charged for these 2 groups, however, families will be responsible for the entry and costume fees associated with these group dances. Dancers may continue to train in the Full Time Program while choosing to opt out of the competitive team and not participate in the classes that are spent focused on choreography, however, there will be no difference in program pricing for these dancers. Technique class time slots **may, on the rare occasion,** be used to complete/clean additional competitive choreography when necessary. In the event this must occur, it will not always be possible for the class time to be rescheduled for dancers who are not a part of that routine.

Tumbling Classes – For dancers in the Teen, Inter and Senior age groups who are interested in furthering their tumbling skills, a tumbling class is available to add on, in addition to their regular company acro classes.

Requirements for participating in tumbling class are:

- side aerial - on the floor, unassisted
- back handspring - on the floor, unassisted

Time Table

Mandatory VS Optional Classes - In the charts below you will find a list of mandatory classes for each program. Optional classes (listed on the lower half of each chart) may be added to your schedule at no extra cost, with the exception of Tumbling.

Starting in October, two technique classes per week will be spent on competitive choreography. Additional competitive routines will be offered in early October - rehearsals for any extra routines are in addition to the below mentioned technique classes. When group choreography begins, technique for the style in which the competitive choreography occurs will be covered in their other weekly classes. For example - if a company does a lyrical group, lyrical technique will be covered in jazz and jumps & turns classes.

Registration/Admin Fee

A once per year (July 1, 2026 – June 30, 2027) non-refundable registration fee of \$33+HST applies to each individual dancer that is registered. Registration fees paid for Summer 2026 mini sessions will be credited forwards towards the 2026-2027 season.

Sibling Discount

Account holders with multiple children dancing at Element Dance Arts are offered an additional savings, regardless of the time of year at which they register. The tuition of the dancer participating in the most technique hours per week is rated at regular cost. Each subsequent dancer, dancing for an equal or lesser amount will receive 5% off their tuition. Dancers must be siblings. Sibling Discount DOES NOT apply to Mini Session programs.

Late Payments

Interest on all overdue accounts shall bear interest at a rate of 5% per month (60% per annum). The 5% late fee will be applied to any payments received more than one-week past due. Failure to make a payment will result in the removal of your dancer from their class until all outstanding payments have been made.

NSF Direct Payments

Any direct payments (ie payments made from a bank account) in which the account is deemed to have insufficient funds are subject to a \$25 service charge. Upon receiving notice of an NSF direct payment, payment must be remitted along with the NSF fee prior to your dancer's next class. Re-payment of direct payments must be made through your Parent Portal or via etransfer to info@elementdancearts.com

Payment Plan

All tuition pricing will be divided into 10 equal installments. Installments do not reflect the number of classes per month but rather an equal payment plan for your convenience. The first installment is due upon registration and is required in order to hold your dancer's spot in class. Each subsequent payment is due on the first of each month (October 1st - June 1st).

All payments are processed through auto-pay within the JackRabbit Parent Portal. **A method of payment must be entered online when registering for classes.** This payment method will be used to process your initial payment upon registration (incl registration fee and first installment towards tuition). This payment method will also be used on the first of each month, October 2026-June 2027 to process your tuition payment. This can be updated or changed at any time.

Direct banking info or credit cards are both accepted. **Visa Debit or MC Debit cannot be processed.**

*Please note: some months have more classes than others. Payment plans **do not reflect the number of classes offered per month** but rather an equal division of the full year's tuition amount.

Withdrawal Policy

We require one-week's written notice prior to the end of the term if you choose to withdraw your child from the program (Term 1: September – December 31st, 2026; Term 2: January 1st – March 31st, 2027; Term 3: April 1st – recital in June 2027).

Refunds are based on term fees, even though tuition is paid on the first of each month. No fees will be refunded if your student withdraws during the final term.

Registration fees are non-refundable. No fees will be refunded once a term has begun.

Uniform & Dress Code

Click here to view the dress code for our Full Time Program classes. Some uniform items can be purchased year-round from the studio or from our website (www.element-dance-arts.square.site).

Ballet class bodysuits may be purchased directly from FreeStyle Dancewear. We will also place a bulk order in the summer for these items, which will be delivered to the studio for your convenience.

Please ensure all parts of your child's uniform are clearly labelled - individual shoes, socks, tights...you'll be amazed at the amount of lost property we generate!

Attendance

Make-Up Classes

Classes that fall during planned closures will not be made-up.

Classes cancelled due to teacher illness will be rescheduled at the earliest convenience, or alternate class options are provided. Families are notified of cancelled classes by email.

Cancellations are also posted on our social media pages, and studio doors.

Weather

Classes cancelled due to inclement weather will not be made-up. We always try our best to keep the studio open as long as it remains safe.

In the event of a Pandemic

In the event of a pandemic and we are required to close the doors to our physical studio space, the remainder of the current month's classes will be transitioned to an online platform. No refunds will be given for the remainder of said month.

Prior to the start of the next month, you will be given the option of withdrawing due to the move to the online platform, or continuing with the online platform.

Year-end Recital

All students who are enrolled in a full-year class are invited to participate in our year-end recital (Mini Session program participants do not participate in recital). **Any dancer participating in the recital must attend ALL performances for which their class is scheduled.**

It is assumed that all dancers enrolled in a full-year class are opting into participating in recital. In January of 2027, a recital information package will be sent home – at this time you'll be given the option to opt-out of participating in the year-end recital. Costumes for Full Time level classes are either a rental costume provided by the studio, or parents are asked to source items on their own. This is communicated closer to the date of recital. Recital routines are not created for Jumps & Turns or Stretch & Strength classes. Classes that have a competitive group choreographed in them will not learn new choreography - these pieces will be performed in recital. Information on any other additional recital routines will be available with recital information in January.

At this point, tentative recital dates are booked for early-mid June. Dates will be confirmed in January of 2027 when our recital information package is released.

Code of Conduct

To ensure the smooth, safe running of Element Dance Arts and an enjoyable experience by all, below you will find our code of conduct. Following a formal meeting, we reserve the right to dismiss or take disciplinary action on any students or parents who breach our studio's code of conduct.

Families who do not comply with their fee or costume payment obligations may be charged a late fee, and/or excluded from performances. External debt collection may occur when fees remain overdue and this will be at the expense of the client. Costume expenses are the responsibility of the parent, and costumes will not be issued to students with unpaid class fees.

No classes (including private lessons) are to be disturbed unless it is an emergency. If messages, food, drink, or medication needs to be passed on to a student, it must be done through the front office staff.

We are unable to take responsibility for our students before or after their scheduled classes and it is the responsibility of the parent to ensure their child is picked up and dropped off on time. In the case of an emergency or unavoidable delay, please contact the studio immediately to inform us of the situation so we can keep your child calm and safe until they can be collected.

Any questions or concerns must go through the office – ie parents and students should not contact the teachers at Element Dance Arts via their personal phone or social media to address questions or concerns. Studio issues should be addressed with the front office staff. Personal meetings with the studio directors can happily be arranged via the office.

Physical, mental, emotional or cyber bullying by parents, staff or students will not be tolerated. In the rare case of a parent or student showing disrespect or defamation to any parent, staff member or student, a meeting will be called and dismissal may be considered at the discretion of the directors.

Element Dance Arts takes no responsibility for any stolen or misplaced property on the studio premises and we encourage our families to avoid bringing valuable items into the studio where possible. Please ensure all uniform items are labelled with your child's name.

Safety

As part of your registration, you will have read and signed a media waiver allowing us to proudly use images and video footage of your student for advertising and promotional purposes. Should you have any concerns whatsoever with signing this declaration, please see our reception staff who will happily assist you.

We have a number of viewing windows within the studio rehearsal space which can be used by parents and family members from the comfort of our lobby. When watching through these windows, we ask that you keep a few things in mind; share the viewing space. There isn't always space for every parent to view at the same time - let your neighbour take a turn watching their talented child in action too! Also - words can be incredibly powerful. When you're watching classes, please choose your words wisely and always speak with kindness.

We enforce a peanut & nut-free policy at the studio to ensure the safety of any students or parents with allergies to nuts or nut products.

You will find within our enrolment system a general liability waiver & assumption of risk. Please read this document carefully and sign it prior to the commencement of classes so you fully understand the rights and responsibilities of your family and our studio.

Privacy

When you register for a program with Element Dance Arts, the information we may collect from you includes your name, address, telephone numbers, email addresses, medical information and credit card or bank details. It may also include details of the products and services we provide to you as well as the status of your enrollment. We only collect information directly from our students or their parent/guardians primarily for the purpose of providing services and products to you and manage invoicing and debt collection.

We will never sell or pass on any of your information to third parties unless required by government authorities or in the event of debt recovery. Any information passed on will be done with appropriate privacy and confidentiality protection.

Information is stored securely in electronic form and is accessible only by authorised personnel.

Policies

Terms & Conditions

This Agreement is between the undersigned ("you") and Element Dance Arts Inc. ("Element Dance Arts"). This Agreement commences on the date you sign it and expires at the end of the final term (June 30, 2027).

THE AGREEMENT By signing this Agreement and paying tuition for your chosen classes, Element Dance Arts will secure a space for your child in those classes. Customer agrees to continue paying tuition until the year ends or the child drops out in the manner provided for below.

TERMS AND METHODS OF PAYMENT One option exists for paying tuition.

You may pay in ten (10) installments. Payments are due on the first of each month. The first payment is due at the time of registration. A pre-authorized debit or credit card agreement must be signed for the nine (9) subsequent payments.

All overdue accounts shall bear interest at a rate of 5% per month (60% per annum).

A \$25.00 fee will be charged for any cheques that are returned NSF (non-sufficient funds).

A \$33 (+ HST) registration fee will apply to all registrations.

YOUR RIGHTS UNDER THE CONSUMER PROTECTION ACT, 2002 You may cancel this agreement at any time during the period that ends 10 days after the later of the day you receive a written copy of the agreement and the day all the services are available. You do not need to give Element Dance Arts a reason for cancelling during this 10 day period. In addition, there are grounds that allow you to cancel this agreement. You may also have other rights, duties and remedies at law. For more information, you may contact the Ministry of Consumer and Business Services. To cancel this agreement, you must give notice of cancellation to Element Dance Arts, at the address set out in the agreement, by any means that allows you to prove the date on which you gave notice. If no address is set out in the agreement, use any address of Element Dance Arts that is on record with the Government of Ontario or the Government of Canada or is known to you. If you cancel this agreement, Element Dance Arts has 15 days to refund any payment you have made and return to you all goods delivered under a trade-in arrangement (or refund any amount equal to the trade-in allowance).

CANCELLATION AND REFUNDS If your child wishes to drop classes, you must provide written notice one week prior to the end of term. Tuition will only be refunded for terms that have not started at the time the child drops out. No refund will be provided for any term already started. No refund will be provided if the dancer is expelled from classes for failure to comply with the behaviour code. Registration fees are non-refundable.

TRANSFER RIGHTS Spaces in Element Dance Arts classes are non-transferable. Each class has a limited number of spaces, which will be filled on a first-come, first-serve basis. In the event that a space becomes available, it will be made available to the first dancer on the waiting-list.

SIBLING DISCOUNT The sibling discount applies to siblings only. It is not available for other familial relationships. A five percent discount is offered on the tuition of the sibling(s) with fewer class hours per week. The sibling with the highest number of class hours per week will pay regular tuition.

DRESS CODE It is important that dancers wear appropriate clothing and footwear when attending classes. Outdoor and/or street shoes are NOT permitted in the studios. Failure to comply may result in the dancer being disallowed from participation in class.

BEHAVIOUR CODE Inappropriate behaviour such as swearing, physical or verbal abuse will result in the loss of all current and future access privileges. Respect for fellow dancers, parents, guardians and all Element Dance Arts staff is expected to be shown at all times. Failure to comply may result in the dancer's expulsion from classes.
